1. We value the trust you place in our company. We will always use your personal data in a way that is fair and worthy of that trust.
2. You are entitled to clear information about how we use your personal information. We will communicate in a transparent way with you about what information we collect, what we do with it, with whom we share it and who you should contact if you have any concerns.
3. We will take all reasonable steps to protect your information from misuse and keep it secure.

PURPOSES OF THE DATA PROCESSING

- you want to exercise your right to data portability;

- you want to report misuse of your personal data.

Within one month of submitting your request, we will inform you of the follow-up given to this request.

You have the right to withdraw your consent to any particular processing at any time, such request not affecting the lawfulness of the processing before your withdrawal.

Finally, you always have the right to lodge a complaint with the supervisory authority (GBA)

WHO DO WE SHARE YOUR PERSONAL INFORMATION WITH?

As a rule, we don't share your personal data with anyone outside ARM LOGISTICS GROUP, unless this is really necessary for the execution of the agreement. The parties we select are carefully screened and guarantee the same protection of your data.

Your data is shared with:

- third parties required to deliver a service to you, such as a subcontractor (a freight forwarder, a carrier or an agent at destination) or the custom authorities
- law enforcement or government authorities when they request us to disclose the information

- processors that provide statistical research and analysis, such as Google;
- processors that provide hosting of this Website and related databases;

TRANSFER OF YOUR PERSONAL DATA

If you move abroad, it is necessary that we transfer your personal data to subcontractors (and their servers abroad) or other carefully selected third parties in other countries, so that they can process the personal data on our behalf.

You should be aware that many countries outside the EU do not offer the same legal protection regarding personal data as you might be used to in your own country. While your personal data are located in another country, they can be viewed by courts, law enforcement agencies and national security authorities in accordance with applicable laws.

Except in the case that we are confronted with a formal request for access to your personal data, we promise that all parties selected by us that process your personal data are obliged to take appropriate security measures to protect your data and only have the right to process the information in accordance with ARM LOGISTICS GROUP' instructions.

PROTECTING YOUR PERSONAL DATA

We take all reasonable precautions to keep your personal information secure and require any third parties that handles or processes your personal information for us to do exactly the same.

Access to your personal information is restricted to prevent unauthorized access, modification or misuse and is only permitted among our employees and agents on a 'need-to-know' basis.

HOW LONG DO WE STORE YOUR DATA?

ARM LOGISTICS GROUP stores your personal data received from you to carry out the removal agreement until five years after the performance of the services.

The data collected from your visit to our website will therefore be stored for as long as required by law and shall not be kept longer than necessary for the processing purposes described above.

CLICKING BEHAVIOR AND VISITOR INFORMATION

Generic website visitor data is recorded. In this context, in particular the IP address of your computer, a username, time of extraction and data that the browser of a visitor

encloses, are recorded and used for statistical analysis of visits and clicks on the website.

Also, we use this to optimize the operation of this website.

We aim to anonymize this data as much as possible. This information will not be disclosed to third parties.
